# Bellagio May 2009

## Bellagio Declaration

1. Effective Climate Action is incomplete without addressing the overall system performance of the Transport Sector.
2. Climate action in the transport sector should recognize co-benefits
3. More Effective Carbon finance mechanisms and associated procedures should catalyze sustainable transport policies, programs and projects

# Launch of SLoCaT Partnership

- SLoCaT was launched on 25 September 2009 in Bangkok
- Voluntary multi-stakeholder initiatives contributing to the implementation of Agenda 21, Rio+5 and the Johannesburg Plan of Implementation (JPOI)
- Guiding principles:
  - Non legal, non binding;
  - Decentralized structure;
  - Partnership members are responsible for the implementation of Partnership activities;
  - Conveners office (Secretariat) is non implementing
- Geographical focus: developing countries in Africa, Asia and Latin America
- Thematic focus: Land transport (passengers and freight)

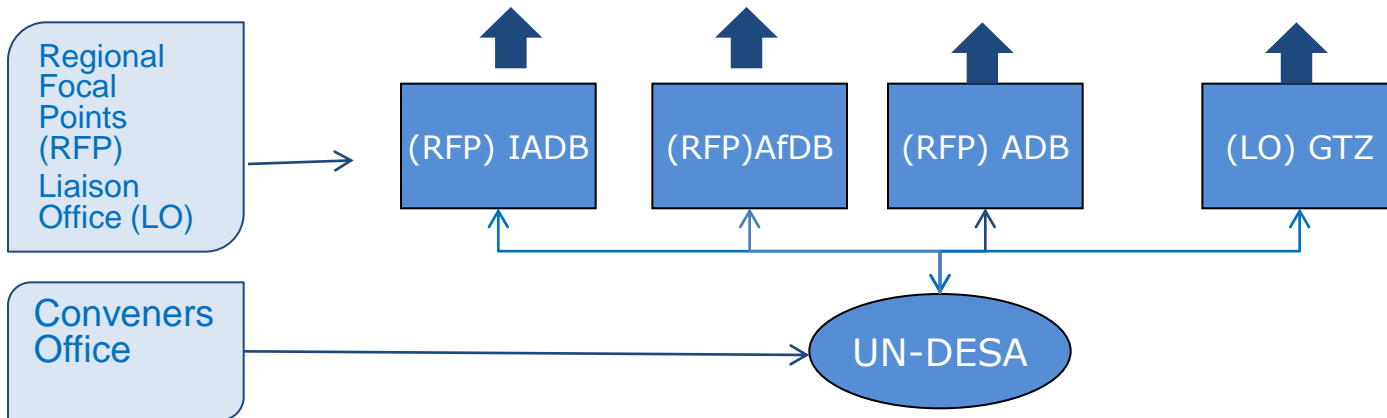
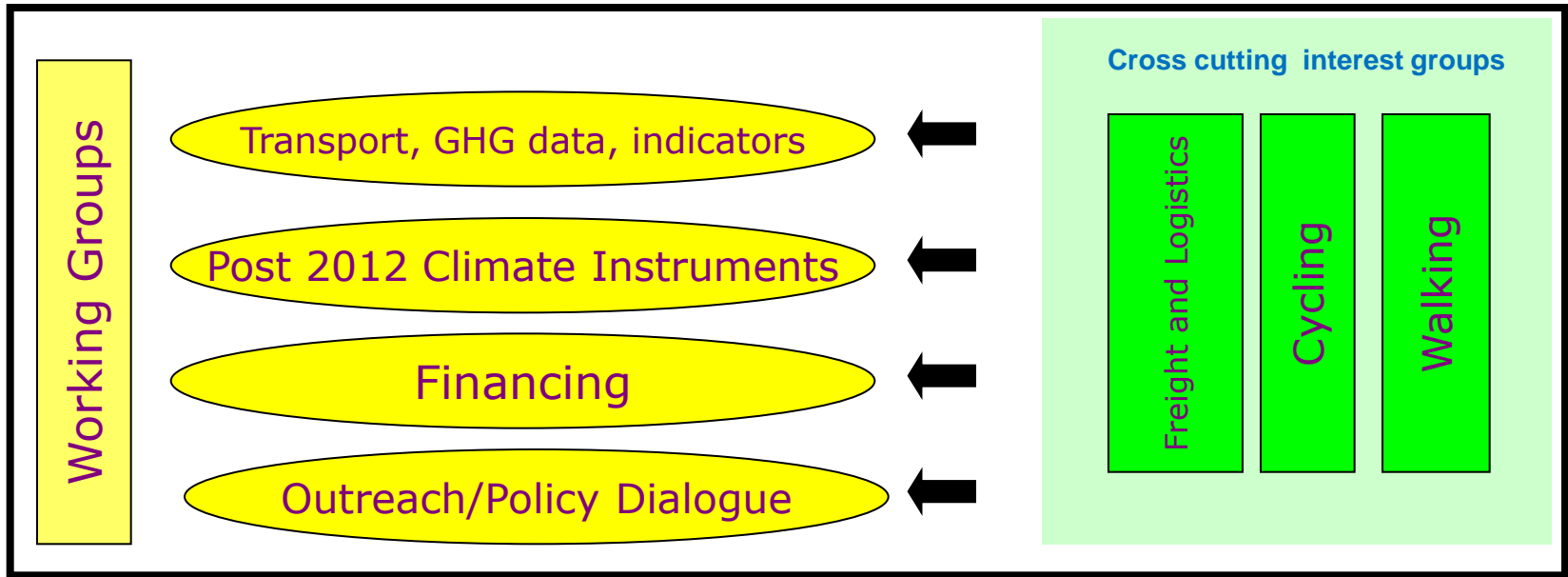


# Partnership Objectives

# SLoCaT Membership

## Membership Criteria:

- a) active commitment to work towards sustainable, low carbon transport and
- b) work at global, regional or national level in one of the membership categories.

- Current membership 53 organizations
- Representing International Development Organizations, International NGOs, Private sector, academe
- Covering Asia, Africa and Latin America

Since beginning of 2010 no active policy to expand membership

# Transport, GHG data, indicators

- Ongoing work by ADB, IDB, CCAP, CAI-Asia Center to map and document existing available data
- Submission on transport data to CSD 18
- Design of future two-track approach
  - UN-DESA, IEA, ITF and others leading intergovernmental process
  - SLoCaT facilitating capacity building on national and local level data
- Expert meeting planned for October 2010



# Post 2012 Climate Instruments

- Active inputs to the UNFCCC climate negotiation process through submissions, side events and lobbying with Bridging the Gap Initiative in lead role supported by others
- ADB-IDB (CITS) project on application of post 2012 climate instruments for the transport sector, with involvement of other SLoCaT members
- Submissions and comments on CDM methodologies
- Peer review of GEF GHG methodology

  - Transforming Transportation, Washington DC, January 2010
- Development of EST Forum Latin America
- Extensive interaction with ADB and IDB with respect to their transport policies and plans
